This indicates a bearish trend. Price is also near the lower Bollinger Band, suggesting strong downside pressure. Momentum indicators support the weakness: MACD is negative, ROC is below zero, RSI around 33, and Stochastic near oversold, all pointing to continued bearish sentiment. |
| Nifty Bank | Technical Outlook for 09-03-2026: Nifty Bank closed at 57,783.25 on 06-03-2026. Nifty Bank is continuing its recent decline and trading below the 14 EMA, 21 EMA, and 50 EMA, indicating a clear short-term bearish trend. The index is now approaching the 200 EMA support, which becomes a critical level for the next session.
